1. No Poster, Banner or Wall Writing is made for awareness to People about NREGS Work.
2. Work entry is not done by the supervisor in Job Cards.
3. Sushen Roy, Job Card No- WB-07-003-009-005/574 was allotted in muster roll no-730 as an unskilled labour in the scheme namely "**All-cum Bundh From Vagnarpar to Fultoli at part 16/129**" but he is a worker of SBI Customer Service Point, Moulani Branch and supervisor confess that Sushen Roy did not work in that scheme.
4. Other labour named Nilu Sen WB-07-003-009-005/139 was allotted in muster roll no. 768 as an unskilled labour in the scheme namely "**All-bundh from kalu to Manik house via sunil via hiren house via Zilla Parisad Road at 16/129**" but he is a teacher of B.F.P. Pry School (Lal School) and supervisor confess that Nilu Sen did not work in that scheme.
5. Subrata Roy, S/O-Manmohan Roy, Job Card no-WB-07-003-009-005/648 and Menoka Roy, W/C-Manmohan Roy, Job Card No. WB-07-003-009-005/572 both are belongs to same family but they have two separate Job Cards. If they belong to same family then they should not keep two separate Job Cards in their custody.

Therefore, you are directed to enquire the above matters specially point No.3 & 4. and submit an Action Taken Report within 17th September, 2014 positively.


Madam,
