Hence, you are directed not to pay them as a semi-skilled labour.

Therefore, you are directed to enquire the above matters and submit an Action Taken Report within 17th September, 2014 positively.

No of point	Action Taken
Point No.2:-Work entry is not done by the supervisor in Job Card.	It is a serious negligency on the part of supervisor as because the job card holder will be unaware of the no of days he worked. Hence not acceptable.
Point No.3: Two labour named Mostafa Golap, S/O: Sapiyar Rahaman and Debasis Sarkar, S/O-Sushanta Sarkar are allotted in muster roll no.139 and 144 as an unskilled labour in the scheme namely "Improvement of Earthen Canal repairing at saraswati canel from H/O-Sudhir to Pakritala(17/77), but both are engaged in that scheme as a supervisor.	As MGNREGS Act any person is not engaged in same scheme as unskilled and semi skilled labour. Hence not acceptable.

Hence, you are now directed to take necessary action US-25 of MGNREGS Act against supervisor Sri Mostafa Golap and Debasis Sarkar.


