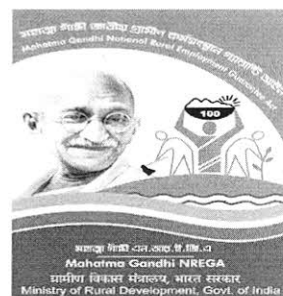

**Sub :- Sub Allotment of fund for raising nursery by SHG under MGNREGS.**
