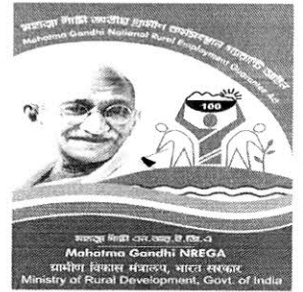

**Sub :- Sub Allotment of fund for raising nursery by SHG under MGNREGS.**

The following funds under MGNREGS amounting to **Rs 4,91,700.00 (Rupees- Four lakh ninety one thousand seven hundred)** only have been sub-allotted as 1<sup>st</sup> installment to the Programme Officers of Blocks of Jalpaiguri district to take up the raising nursery schemes by SHGs from AAP-2011-12 as detailed below under MGNREGS with immediate effect.
