

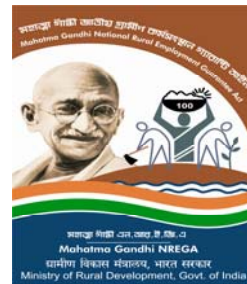



ORDER

Subject: Amendment to Post Office Accounts Rules.

Vide notification dated 24th December, 2012, Ministry of Finance has amended the notification that stipulated that no deposit other than MGNREGA wage can be made in the accounts opened for MGNREGA wage earners.

2. As per the amendment, wages under MGNREGA, Government benefits and deposits can now be made in to such accounts. A copy of the notification is attached.

Notification

G.S.R.(E)..... In exercise of the powers conferred by section 15 of the Government Savings Banks Act, 1873 (5 of 1873), the Central Government hereby makes the following rules further to amend the Post Office Savings Account Rules, 1981, namely:-

- 1.-(1) These rules may be called the Post Office Savings Account (Amendment) Rules, 2012.
- (2) They shall come into force on the date of their publication in the Official Gazette.
2. In Post Office Savings Account Rules, 1981, in rule 4A, in the Table, -
 - (a) against serial number 1 relating to Single Account,-
 - (i) under column (5), for the entries, the following entries shall be substituted, namely:-
"Wages under NREG Act, Government benefits and deposits under these rules";
 - (ii) under column (6), in the entries, the words "and Wage Slip" shall be omitted;
 - (b) against serial number 2 relating to Joint Account,-
 - (i) under column (5), for the entries, the following entries shall be substituted, namely:-
"Wages under NREG Act, Government benefits and deposits under these rules";
 - (ii) under column (6), in the entries, the words "and Wage Slip" shall be omitted.
