Sub: -Opening of fresh NREGS account against the accounts opened with SB Block.

It is observed that many NREGS accounts opened with SB Block in past are running with minus balance. Not only that these accounts are not reflected in MGNREGS scheme also. As a result some difficulties are arisen for collection of actual data of this scheme. It creates a lot of problems in accounting system. So, it is necessary to open a fresh NREGS account in the name of such beneficiaries keeping their past accounts as SB accounts.

For the above purpose all the SPMs of this Division are hereby directed to identify these types of accounts and take sincere efforts for opening fresh NREGS account against those accounts opened with SB Block in past in co-ordination with the Gram Panchayets. The ~~past~~ ^{old} accounts under SB Block may be continued as SB account. A copy of the list of such accounts may please be forwarded to this office. This may please be treated as most immediate.
