



## Sub: - Multiple channels for registering Demand for Mahatma Gandhi NREGA.

To implement the various provisions outlined in Mahatma Gandhi NREGA Operational Guidelines, 2013 and to ensure that the demand for work under Mahatma Gandhi NREGA do not go unregistered the following initiatives will be implemented henceforth:

- 1. All the Gram Panchayat Members, ICDS Centres, Primary & High Schools, SHGs & the Tathya Mitra Kendra is authorized to keep the Form 4A and distribute to the interested workers.
- 2. Form 4a will be provided by the Gram Panchayats in sufficient numbers to all the Gram Panchayat Members, ICDS Centres, Primary & High Schools, SHGs & the Tathya Mitra Kendra.
- 3. All the Gram Panchayat Members, Anganwadi workers, school teachers, members of SHGs, and the Tathya Mitra Kendra functionaries will be authorized to receive work applications and issue dated receipts. All such applications for work should be reported back to the concerned Gram Panchayat without loss of time and the Gram Panchayat will be responsible for collection of all such work applications.

To make the job card holders fully aware about the above – stated mediums and sources for registration of work under Mahatma Gandhi NREGA, the Block & Gram Panchayat should initiate appropriate IEC campaigns including wall writing etc. for its wide dissemination.
