



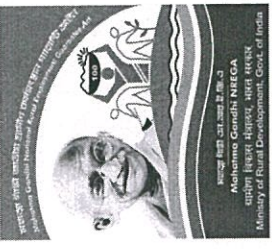

Madam/Sir,

Kindly find enclosed the notification dated 23.03.2016 issued by the Ministry of Rural Development, Government of India of Sub-section (1) of Section 6 of the Mahatma Gandhi National Rural Employment Guarantee Act, 2005 wherein wage rate for Un-skilled manual workers in West Bengal has been raised to Rs. 176.00 per day. This order takes effect from 01.04.2016.

Accordingly wage to all MGNREGA workers shall be paid with effect from 01.04.2016 as per the following table.

| Sl.No. | Category of worker | Wage per day |
|--------|---------------------|--------------|
| 1 | Un-Skilled worker | Rs. 176.00 |
| 2 | Semi-Skilled worker | Rs. 264.00 |
| 3 | Skilled worker | Rs. 352.00 |

Please ensure that with effect from 01.04.2016 all wage payment under MGNREGA are made by following this schedule only.

Sir/Madam,

- I am directed to forward herewith a copy of the Government of India Extraordinary Gazette Notification No. S.O. 1205(E) dated 23rd March, 2016, issued on the above subject for information and necessary action.
- As already intimated vide MoRD letter of even number dated 23.03.2016, the Election Commission of India has conveyed "No Objection" to the revision of wage rates in respect of States of West Bengal, Assam, Kerala, Tamil Nadu & Puducherry subject to the following conditions:-
 - Absolutely no publicity in this regard shall be made in electronic, print, radio, internet or any other media, in any form whatsoever.
 - No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
 - These restrictions on publicity will be applicable to the Central Government as well as the State Government.
 - The relevant provisions of Model code of conduct issued by the Commission shall be strictly followed.


